


The electric cooperative will provide assistance in planning for a safe environment for everyone working and living around grain bins. The State of Iowa requires specific clearances for electric lines around grain bins, with different standards for those filled by portable and permanent augers, conveyors and elevators.

The drawing at right depicts the specific clearances required for both scenarios. If you have any questions concerning the drawings, please contact Farmers at (800) 397-4821.


According to the Iowa Electric Safety Code found in Iowa Administrative Code Chapter 199 -- 25.2(3) b. An electric utility may refuse to provide electric service to any grain bin built near an existing electric line which does not provide the clearances required by the American National Standards Institute (ANSI) C2-2017 "National Electrical Safety Code," Rule 234F. This paragraph "b" shall apply only to grain bins loaded by portable augers, conveyors or elevators

and built after September 9, 1992, or to grain bins loaded by permanently installed augers, conveyors, or elevator systems installed after December 24, 1997. (As adopted by the Iowa Utilities Board)

The cooperative is required by the Iowa Utilities Board to provide this annual notice to farmers, farm lenders, grain bin merchants, and city and county zoning officials. If you have any questions concerning clearance regulations, please call the Farmers Electric Cooperative office.

## Call 8-1-1 Before You Dig

If you're trying to cram in those last few outdoor projects before the snow flies for good, your cooperative wants to remind you to call 8-1-1 before you begin digging.

Any project that requires you putting the shovel into the ground must be preceded by a phone call to 8-1-1. It could be installing a new mailbox, fence, planting a

tree, doing some landscaping or installing a deck.



Don't assume digging even a

small hole isn't dangerous. There are so many underground utilities and some of them are close to the surface. Striking one of these lines can cause injury or death, not to mention fines and repair costs. A quick call to 8-1-1 can avoid any unnecessary danger. After all, it's free and it's the law.

Once you call, an operator will ask a few quick questions and then notify natural gas and power utilities, communications companies, and the proper city personnel for your town. Within 48 hours (excluding Saturday, Sunday or legal holidays), the utilities will come out and either mark their underground facilities with color-coded marks or flags or notify Iowa One Call that it has no lines in the area.

If a contractor is performing the work for you, make sure they have called Iowa One Call prior to excavating.

## Loaded Tater Tots Skewers

#### INGREDIENTS

Bag of frozen tater tots Bacon, chopped Cheddar cheese, grated Ranch dressing seasoning packet Skewers Green Onion (optional)



Preheat oven to 425. Spread tots in single layer on baking sheet and cook according to directions until golden brown. When done baking, let cool for approximately 2-5 minutes. Load skewers with tater tots, approximately six per skewer. Place back on baking sheet. Sprinkle ranch seasoning, bacon and cheese on tater tots and place back into oven for an additional 10 minutes or until cheese is fully melted and golden in color. Top with green onion if desired.

## Jalapeño Popper Crescent Ring

#### INGREDIENTS

8 oz. cream cheese, softened
2 c. diced, cooked chicken
1 c. grated cheddar cheese
3 small jalapeños, diced
2 cans (8 oz.) Pillsbury<sup>™</sup> refrigerated crescent rolls
Ranch dressing, for serving

Preheat oven to 375. Line a large baking sheet with parchment paper. Combine cream cheese, chicken, cheddar, and jalapeños in a medium mixing bowl and stir well. Unroll crescent rolls and lay the long end out in a ring, overlapping them to form the base. The center circle should be about 5 inches in diameter. Spoon the filling mixture along the base of the crescent ring. Bring each dough triangle up over filling, tucking dough under bottom layer of dough to secure it. Bake for 20 minutes or until golden brown. Serve hot, with ranch dressing for dipping.
