# Linemen Practice Vital Rescue Techniques

In an emergency situation, Farmers Electric linemen must know the quickest, safest and most practical way to rescue their partner if contact with an energized power line is made

With thousands of volts of electricity running

through power lines at any given time, it can take only a split second for a lineman to be rendered unconscious, injured or electrocuted.

Being able to perform a pole top rescue requires hours of rigorous training that emphasizes diligence and safety for all. In a simulated pole top rescue scenario, linemen must climb the pole, secure a rope around a 150-pound dummy, lower it to the ground, and begin lifesaving procedures.

Farmers Electric linemen are tested regularly on these vital skills and must be able to perform them correctly in accordance with Occupational Safety and Health Administration (OSHA) guidelines.



# Contact Us When Planning for New Grain Bin

**W**hen you start to plan for a new grain bin, please contact Farmers Electric Cooperative.

The electric cooperative will provide assistance in planning for a safe environment for everyone working and living around grain bins. The State of Iowa requires specific clearances for electric lines around grain bins, with different standards for those filled by portable and permanent augers, conveyors and elevators.

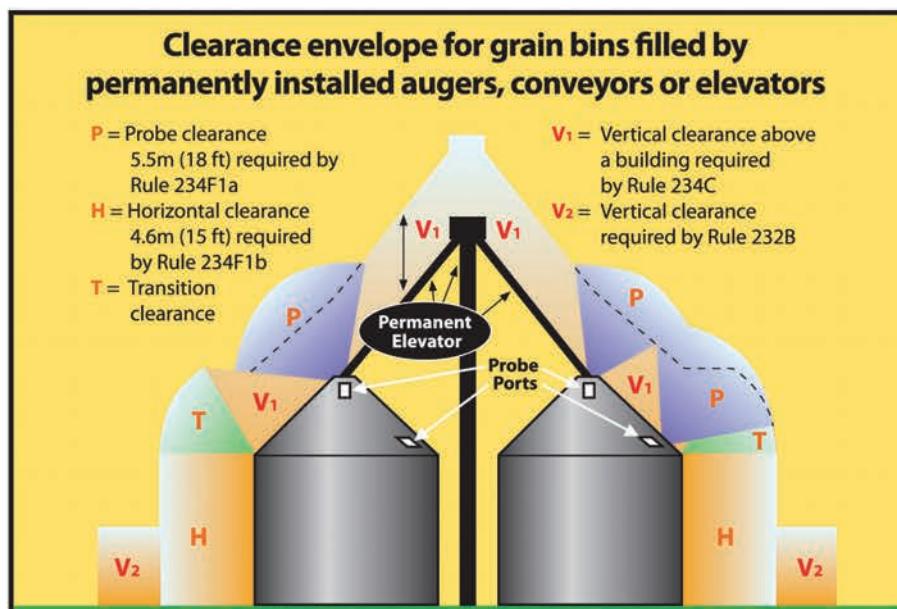
The drawing at right depicts the specific clearances required for both scenarios. If you have any questions concerning the drawings, please contact Farmers at (800) 397-4821.

According to the Iowa Electric Safety Code found in Iowa Administrative Code Chapter 199 -- 25.2(3) b. An electric utility may refuse to provide electric service to any grain bin built near an existing electric line which does not provide the clearances required by the American National Standards Institute (ANSI) C2-2017 "National Electrical Safety Code," Rule 234F. This paragraph "b" shall apply only to grain bins loaded by portable augers, conveyors or elevators and built after September 9, 1992, or to grain bins loaded by permanently installed augers, conveyors, or elevator systems installed after December 24, 1997. (As adopted by the Iowa Utilities Board)

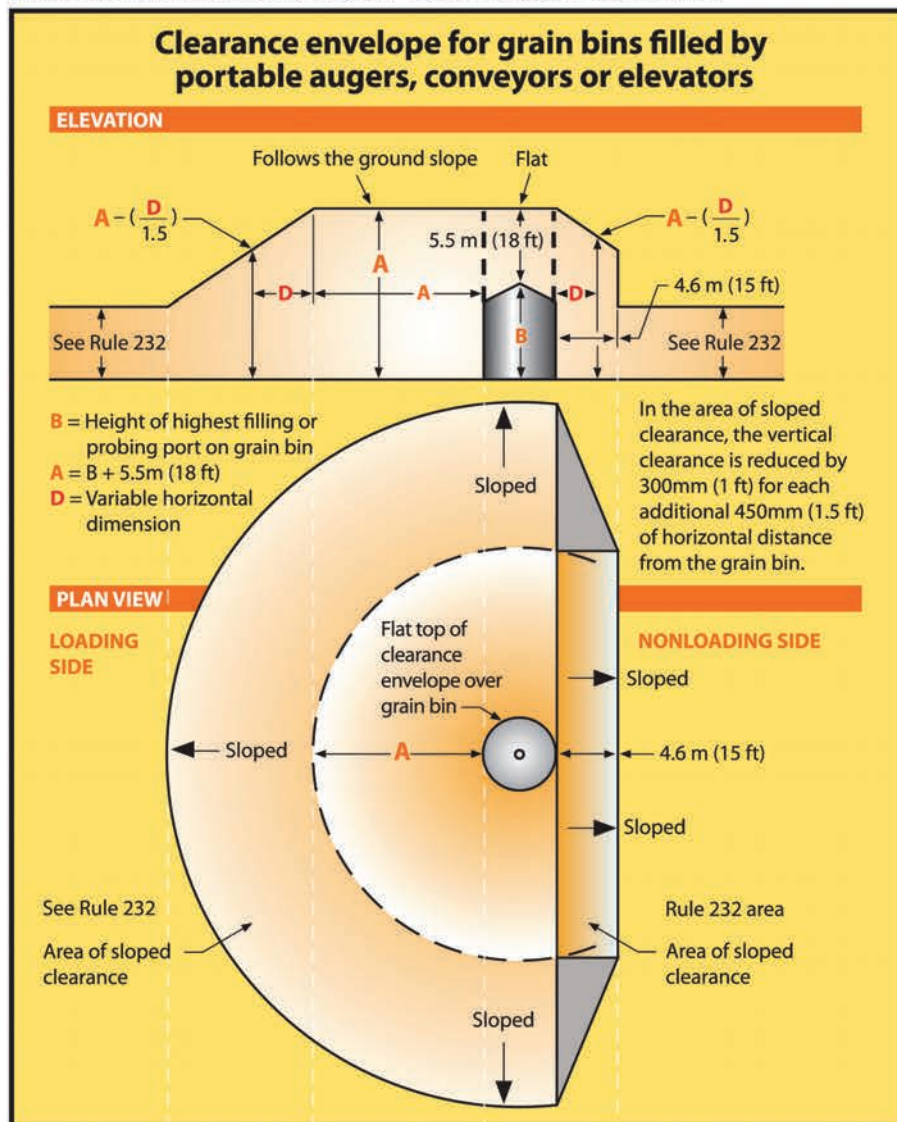
The cooperative is required by the Iowa Utilities Board to provide this annual notice to farmers, farm lenders, grain bin merchants, and city and county zoning officials. If you have any questions concerning clearance regulations, please call the Farmers Electric Cooperative office.

## 5 STEPS FOR SAFE DIGGING

Working on an outdoor fall project? Careless digging poses a threat to people, pipelines and underground facilities. Always call 8-1-1 first. Here are five steps for safe digging:



### 1. NOTIFY

Call 8-1-1 or make a request online 2-3 days before your work begins. The operator will notify the utilities affected by your project.



### 2. WAIT

Wait 2-3 days for affected utilities to respond to your request. They will send a locator to mark any underground utility lines.



### 3. CONFIRM

Confirm that all affected utilities have responded to your request by comparing the marks to the list of utilities the 8-1-1 call center notified.



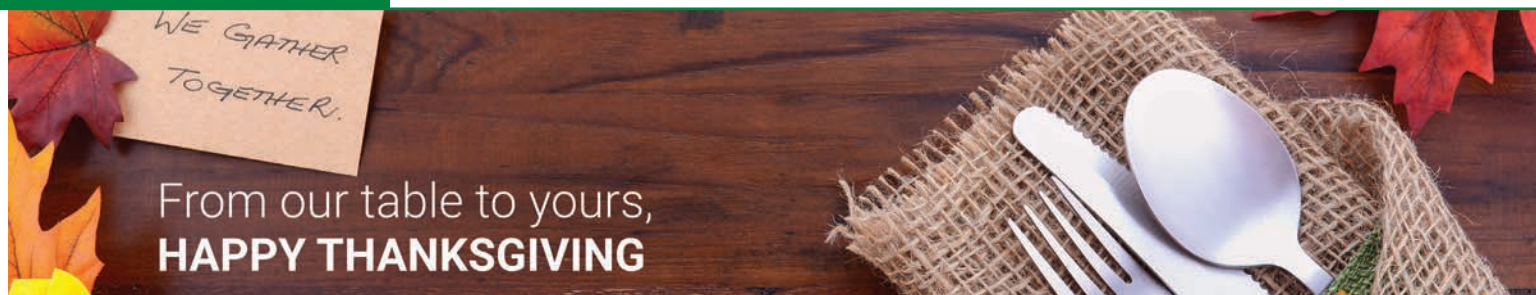
### 4. RESPECT

Respect the markers provided by the affected utilities. The markers are your guide for the duration of the project.

### 5. DIG CAREFULLY

If you can't avoid digging near the markers (within 18-24" on all sides, depending on state laws), consider moving your project location.

## Corn Macaroni Casserole

### INGREDIENTS

1 c. uncooked elbow macaroni  
1 15 oz. can 15 corn (do not drain)  
1 14.2 oz can creamed corn  
1/2 c. (one stick) butter, cubed  
8 oz. Velveeta® cheese, cut into 1/2" cubes  
Salt and pepper

Preheat oven to 350 and grease a casserole dish with nonstick cooking spray. Add macaroni, cans of corn, butter and cheese. Season with salt and pepper and mix well. Cover tightly with foil and bake for 30 minutes. Remove foil and stir well. Return to oven uncovered for an additional 30 minutes until bubbly.

## Cake Mix Cookies

### INGREDIENTS

1 (15 oz.) box cake mix (I used Betty Crocker™ Delights Super Moist Spice Cake Mix, but any will work.)

1 c. canned pumpkin puree (NOT pumpkin pie filling)

1 large egg

1/2 c. butterscotch baking chips or any other mix-in you prefer (raisins, dried cranberries, chocolate chips, white chocolate chips, toffee bits, chopped pecans for example)

Optional frosting

1/4 c. butter, softened

4 oz. cream cheese, softened

2 c. powdered sugar

1/2 tsp. vanilla

Sprinkle of pumpkin pie spice or cinnamon over the top

Preheat oven to 350. In large mixing bowl, combine cake mix, pumpkin and egg and mix with electric mixer. Gently fold in butterscotch baking chips or whatever add-in you're using. Use a cookie dough scoop to evenly scoop 36 cookies onto a greased cookie sheet or a cookie sheet lined with parchment or a silicone mat. Bake 10-12 minutes. Remove from oven and cool for a few minutes before removing to a cooling rack.

Optional frosting: With electric mixer, beat softened (room temperature) butter and cream cheese until creamy (about 2 minutes) at medium-high speed. Add the powdered sugar and vanilla and beat until smooth and creamy. Frost cooled cookies and, if desired, sprinkle the tops of the cookies with a little pumpkin pie spice or cinnamon.
