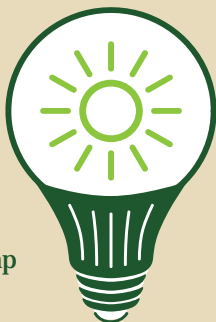

Energy Efficiency Tip of the Month

Mid-winter is a great time to ensure you're making the most of your home heating system. Replace or clean filters to keep your furnace or heat pump running efficiently.



Listen for strange noises and check for uneven heating – these signs indicate that the system may need servicing. Ensure vents and radiators aren't blocked by furniture or rugs as proper airflow helps your system work less and saves energy.

A little maintenance along the way can prevent costly repairs and keep your home cozy through the winter.

More than 150 senior staff and directors from Iowa's electric cooperatives, including Farmers Electric Cooperative, welcomed legislators Jan. 13 in downtown Des Moines.

The annual event draws co-op advocates to discuss upcoming priorities during the 91st Iowa General Assembly. The annual event is sponsored by the Iowa Association of Electric Cooperatives, the Iowa Biotechnology Association, the Iowa Communications Alliance, the Iowa Institute for Cooperatives and FUEL Iowa.

Priorities

1. Protect Iowa's defined electric service territories to ensure every corner of the state receives consistent, cost-effective electric service.

2. Strengthen penalties to further protect utility workers who encounter threats, harassment and assaults while on the job.

3. Third party solar (community solar) programs undermine defined electric service territory by allowing a non-utility to provide retail electric service within a public utility's territory.

2026 STUDENT SCHOLARSHIP

Every year, Farmers Electric supports the youth in our community who have goals to continue their education beyond high school.

Do you know a student who could benefit from financial support as they embark on their future? The co-op will award \$10,000 in scholarships for seniors whose parents are members and reside in our service territory. The scholarships can be used for college or vocational technical schools.

REQUIREMENTS

Deadline: Wednesday, April 1.

Application must include:

- Copy of student's transcript;
- A typed essay on "What are 5 major differences between being a member of an electric cooperative rather than a customer of an investor-owned utility?"; and
- A senior photo.

No other attachments are allowed.

Student must be enrolled full time at an accredited college, university or vocation or technical school for 2026-2027 school year.

Student must have parent or legal guardian who is a member of Farmers Electric and resides within the cooperative's service territory.

Children or grandchildren of directors are not eligible.

The scholarship award will be issued after completion of the first semester and sent directly to the college.

The cooperative has set aside a total of \$10,000 to be awarded to students based on their application and number of submissions.

GRANDMA D'S BROWNIES

- 1 stick margarine
- 1 c. sugar
- 4 eggs
- 1 16 oz. can Hershey syrup
- 1 c. + 1 T. flour
- Frosting:**
- 6 T. margarine
- 1 ½ c. sugar
- 6 T. milk
- 1/2 c. chocolate chips

With electric mixer, beat together margarine, sugar and eggs until fluffy. Alternating, add Hershey syrup and flour, beating until smooth between each addition. Spread in 11" x 15" pan. Bake at 350 for 30 minutes.

Frosting: Combine margarine, sugar and milk in saucepan until mixture comes to a boil. Boil 30 seconds. Remove from heat and add chocolate chips. Stir until smooth and let it cool a bit before frosting brownies.

CHOCOLATE REVEL BARS

- 1 c. margarine
- 2 c. brown sugar
- 2 eggs
- 2 tsp. vanilla
- 2 1/2 c. flour
- 1 tsp. baking soda
- 1 tsp. salt
- 2 1/2 c. quick oats

Filling:

- 1 12 oz. pkg chocolate chips
- 1 15 oz. sweetened condensed milk
- 2 T. margarine
- 1/2 tsp. salt
- 2 tsp. vanilla
- 1 c. chopped nuts (optional)

Cream together margarine, brown sugar and eggs until fluffy. Add flour, baking soda, and salt; then stir in oats. Pour 2/3 of mixture into greased jellyroll pan.

To make filling, melt chocolate chips, margarine, milk, and salt in saucepan. Stir in vanilla and nuts. Spread over batter. Dot the remaining 1/3 batter over the filling. Bake at 350° for 20-25 minutes or until golden brown.
